Thank you for your interest in being a contestant in the Mr. So Cal Bear / Cub Contest during BearQuake 2010. A Contestant Application is enclosed.

Please note that we are limiting the total number of contestants to 10, **strictly determined by the order in which the Contestant Applications are received**. Regardless of whether we receive 10 applications or not, we must receive your completed application no later than **Thursday, September 30, 2010**. We encourage you to complete and return it promptly.

The **Mr. So Cal Bear / Mr. So Cal Cub Contest** will be held on **Saturday October 16, 2010**. Titles will be awarded for **Mr. So Cal Bear and Mr. So Cal Cub**. The judges will choose the winner of this title from the total pool of contestants.

Contestants must be registered attendees of **BearQuake 2010**. In addition, contestants are required to participate in a number of additional activities during BearQuake, including:

- Friday, October 15 at 8 PM until midnight, Meet n' Greet at Pecs Bar.
- Friday, October 15 from 9 PM until 11:30 PM, contestants will sell raffle tickets at Pec's to help raise money for our charities.
- Saturday, October 16 from 3 PM until 9 PM, contestants will participate in the Mr. So Cal Bear / Mr. So Cal Cub Competition at Rich's San Diego.
- Sunday, October 17 from 4 PM until 8 PM, contestants will participate in the Victory Celebration at The Hole.

The competition will begin with the introduction of the contestants in "Bear Wear". The contestants will then appear in the fantasy or "bear minimum" segment (use your imagination, but please, no genital display). Following intermission, the contestants will compete in the "bear cruise wear" segment, during which each contestant will be required to deliver a one-minute speech on a topic to be determined by the judges. The time limit for this speech will be strictly enforced. If spoken English is not your native language, please let us know on your application so that we can arrange to have a translator available. Points will be awarded for each segment of the competition, as well as for the interviews and for raffle ticket sales.

Remember, participation in the competition is limited to the first 10 applications received by registered attendees, so return your application as soon as you can. After signing and mailing the application, please email a head-shot (JPEG) of yourself to contestants@bearssd.org Please note that an e-mail confirmation of receipt will be sent out immediately, however acceptance letters will not be sent out until after the receipt of the first 10 applications, or until after the receipt deadline, whichever comes first.
